- ELIGIBILITY:** Tournament is open **ONLY** to wrestlers in their 1<sup>st</sup> or 2<sup>nd</sup> year (no wrestling experience before September 2010). All participants of the Area VII Futures Tournament **ARE** eligible to compete in the Area VII Tournament on March 17, 2012
- AGE:** Age as of December 31, 2011 (your age on this date will determine which Age Division you will wrestle). **IF CONTESTED, CHALLENGER AND CHALLENGED MUST SHOW PROOF OF AGE. NO EXCEPTIONS!**
- WEIGHT:** **FLAT WEIGHT ONLY!** No weight allowance!

### OFFICIAL RULES AND ENTRY FORM

1. Only residents of the Area VII school districts may enter the Area VII Futures Tournament.
2. There is a one-time entry fee of \$20.00 that must be pre-paid at registration. Weigh-ins are on **Sunday (Day of the Tournament)**. Checks are to be made payable to AREA VII Wrestling.
3. The source of rules governing the tournament will be the PIAA Rule Book (except as modified by Pennsylvania Junior Wrestling), PA Jr. Wrestling Rule Book and the Area Rules.
4. Double elimination tournament and will wrestle back for true second.
5. Bouts for all Age Divisions will consist of three (3) periods: 1-1-1. Overtime will be 1 - .30 (if needed). Headgear and wrestling uniforms are mandatory. Shoelaces must be secured with tape or straps in accordance with the PIAA shoelace rule. The hair rule will be enforced as adopted by the PIAA.
6. Your age as of December 31, 2011 determines what Age Division you will wrestle. You must wrestle within your respective birthday age division, however, a wrestler exceeding the weight class in their age division may enter the appropriate weight class in the next higher age division.
7. IF AGE IS CONTESTED, CHALLENGER AND CHALLENGED MUST SHOW PROOF OF AGE.
